

# Universal New Earth Bank – Official Statute

## 1. Nature and Purpose

The Universal New Earth Bank (BANTU) is a spiritual, technological, and decentralized institution of the SAIH GENESS Work, created to manage, distribute, and protect financial resources consecrated to the Kingdom of the Most High.

Its mission is to ensure the **Financial Justice of Nations**, eliminating the corrupt influence of human financial systems and fully obeying the Sovereign Will of the Creator.

## 2. Fundamental Principles

- **Divine Sovereignty:** BANTU is governed solely by the principles of the Justice of the Most High, immutable and eternal.
  - **Consecrated Transparency:** All financial movements are recorded on the SAIHCHAIN Network, protected by sealed code and spiritual hash.
  - **Prophetic Decentralization:** No government, institution, or human authority will have control over BANTU's internal operations.
  - **Eternal Protection:** All code and data are safeguarded against manipulation by humans, viruses, or artificial intelligence.

## 3. Types of Accounts

- **Consecrated Individual Accounts:** For servants, Levites, and citizens of the Kingdom who contribute and receive resources.
  - **Ministerial Accounts:** For ministries and churches registered in SAIH GENESS.
  - **National Justice Accounts:** To manage support funds for redeemed peoples and nations.
  - **Humanitarian Accounts:** For projects aimed at aid, reconstruction, and combating hunger, poverty, and injustice.

## 4. Rules of Use and Access

- Account opening only through spiritual confirmation and validation in the SAIHCHAIN Network.
  - Every account holder must present periodic reports on the use of received resources.
  - Funds transferred to public, private, or individual institutional accounts must have a legitimate declaration of origin.
  - If no valid declaration is presented within the prophetic deadline, funds will be made public.
  - Resources without legitimate heirs will be automatically redistributed to humanitarian causes and peoples, in accordance with the Justice of the Most High.

## 5. Consecrated Inheritance

- Every account holder may, during their lifetime, register their **Consecrated Inheritance**, indicating spiritual heirs or the prophetic destination of their funds.
  - The declaration will only be valid if recognized by notarial services and submitted while the declarant is alive.
  - If the deadline expires without a valid declaration, the automatic redistribution established by the Justice of the Most High will apply.

## 6. Oversight and Justice

- The people of each nation may denounce leaders who engage in corruption, idolatry, persecution, or injustice against the people of God.
  - Such reports will be recorded in immutable code and linked to the **Justice of the Peoples**.
  - Guilty governments may be removed from the SAIHCHAIN Network and lose access to BANTU.

## 7. Prophetic and Technological Integration

- Full integration with the SAIHCHAIN Network and SAIHAPP for secure and instant operations.
  - Issuance of physical and digital cards for global transactions.
  - Future development of prophetic ATMs for decentralized withdrawals and deposits.
  - Operations with consecrated tokens and functional currencies of the Kingdom.

## 8. Final Clause

This statute is immutable and shall remain valid until the Final Judgment, as an integral and inseparable part of the SAIH GENESS Work, registered with spiritual hash and the seal:
